WHEREAS the Petitioner above named through his Advocate Sri. MOHD ANWAR ALI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction, more particularly one in the nature of Writ of Mandamus, declaring the action of the Respondent Nos. 7 to 12 in interfering with the peaceful functioning and activities of the Petitioner Committee, and in obstructing the usage of the Christian Burial Ground situated in Sy. Nos. 1, 10, 11 and 12 (part), Parvathapur Village, Medipally Mandal, Medchal-Malkajgiri District, including illegally locking the burial ground gate and preventing burial of dead bodies, as illegal, arbitrary, unconstitutional and violative of Articles 14, 21 and 25 of the Constitution of India and consequently direct the Respondent authorities, particularly Respondent Nos. 3 to 5, to provide necessary police protection and ensure that Respondent Nos. 7 to 12 do not interfere with the administration, maintenance, and use of the Christian Burial Ground by the Petitioner Committee and further direct the official respondents to take appropriate action on the complaints submitted by the Petitioner dated 11.02.2026 and ensure uninterrupted access for burial activities.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. MOHD ANWAR ALI Advocate for the Petitioner, Mr. L. Ravinder, learned Assistant Government Pleader for Revenue, directed issue of notice to the Respondent Nos.6 to 12 herein to show cause as to why this WRIT PETITION should not be admitted.
