MOHD AMJAD ALI ANSARI presented this Petition under Section 528 of B.N.S.S. praying that in the circumstances stated in the grounds filed in support of the CRIMINAL PETITION, the High Court may be to set aside the cognizance taken on dt.31/03/2017 in C.C.No.347 of 2017 (Prl. J.C.J. Cum -V Metropolitan Magistrate, Medchal Malkajgiri District now falls under XXI Metropolitan Magistrate, Cyberabad at Medchal. against the Petitioner/A1 .

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. MOHD AMJAD ALI ANSARI Advocate for the Petitioner, PUBLIC PROSECUTOR for the respondent No. 1 directed issue of notice to the Respondent No. 2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

**I.A. NO: 1 OF 2026**

Petition under Section 528 of B.N.S.S. praying that in the circumstances stated in the grounds filed in support of the CRIMINAL PETITION, the High Court may be to stay all further proceedings against the petitioner/A-1 taking cognizance on dt.31.03.2017 in C.C.No.347 of 2017 (Prl. J.C.J. —Cum-V Metropolitan Magistrate, Medchal Malkajgiri District now falls under XXI Metropolitan Magistrate, Cyberabad at Medchal, pending disposal of CRLP No 6281 of 2026, on the file of the High Court.

**The Court made the following:**

**ORDER**

**Upon perusal of the record, it reveals that the learned Magistrate has taken cognizance without assigning any reasons and issued summons to the accused without recording the satisfaction, which is contrary to the principles laid down by the Hon'ble Apex Court in *Sunil Bharati Mittal v. Central Bureau of Investigation*<sup>1</sup> and *Fakhruddin Ahmad v. State of Uttaranchal and another*<sup>2</sup>.**

**Learned counsel for the petitioner submits that the matter before the trial Court has not been ripened for trial yet.**

**In view of the above, issue notice before admission.**

**Learned counsel for the petitioner is permitted to take out personal notice to respondent No.2 through speed post with acknowledgment due and file proof of service.**

**Post on 09.06.2026.**

**The presence of the petitioner/accused No.1 in C.C.No.347 of 2017 on the file of the Principal Junior Civil Judge-cum-V Metropolitan Magistrate, Medchal, presently XXI Metropolitan Magistrate, Cyberabad, at Medchal, is dispensed with, subject to the condition that he shall be represented through his counsel on each and every date of hearing. If the presence of the petitioner/accused No.1 is required, he shall appear before the trial Court. In case of non-appearance on the specific date fixed by**
