WHEREAS the Petitioner above named through his Advocate SRI DIGVJAY JAIN presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction or any other appropriate Order in the nature of a WRIT OF MANDAMUS or any other writ or Writs Directing Respondents 1 to 4 to forthwith and in a time-bound manner execute the Eviction Order dated 03.10.2024 in Proceedings No. B/1986/2021 by removing Respondents 5 and 6 and all persons claiming through them from Government land in T.S. No. 132, Block-L, Ward-214, Shaheer-e-Hyderabad Village, treating the said occupation as group encroachment under the Land Encroachment Act and further directing the concerned authorities to Expediently dispose-off the Appeal by Impleading petitioner and without granting any stay without the leave of this Hon'ble Court, to recover all illegal commercial gains derived from the said encroachment as arrears of

land revenue, to restrain all municipal authorities from granting any licences, permissions, utilities or recognition in favour of Respondents 5 and 6 or persons claiming through them, to register criminal cases for encroachment and allied offences, and to enforce compliance through continuing mandamus with periodic status reports to this Hon'ble Court, together with such interim and other appropriate orders as this Hon'ble Court may deem fit and proper in the interests of justice and for the protection of Government land.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of SRI. DIGVJAY JAIN Advocate for the Petitioner, directed issue of notice to the Respondent Nos.5 and 6 herein to show cause as to why this WRIT PETITION should not be admitted.

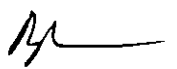
Issue notice to respondent Nos.5 and 6.
