COMMON ORDER

These Criminal Petitions have been filed seeking to release the cell phones of the petitioners namely iPhone 13 128 Gb and Redmi 6i bearing Ph.No.6281927597, respectively, seized in respect of F.I.R.No.31 of 2026 of Kathalpur Police Station, Jagital District, wherein the petitioners were arrayed as accused Nos.1 and 3, registered for the offences under Sections 303(2) of the

Bharatiya Nyaya Sanhita, 2023 (for short 'BNS'), Section 3 of the Prevention of Damage to Public Property Act, 1984 (for short 'PDPP Act'), Section 21(4) of The Mines and Minerals (Development and Regulation) Act, 1957 (for short 'MMDAR Act') and Sections 180, 181 and 184 of the Motor Vehicles Act, 1988 (for short 'MV Act').

2. Heard Mr. K. Venumadhav, learned counsel for the petitioner, and Mr. Jithender Rao Veeramalla, learned Additional Public Prosecutor for the respondents.

3. Learned counsel for the petitioners submitted that the petitioners are accused Nos.1 and 3 in respect of F.I.R.No.31 of 2026 of Kathalpur Police Station, Jagital District. In connection with the said crime, the Police seized their mobile phones i.e., iPhone 13 128 Gb and Redmi 6i bearing Ph.No.6281927597, respectively and the petitioners filed applications vide Crl.M.P.Nos.63 and 64 of 2026 on the file of Judicial Magistrate of First Class at Korutla, seeking return of the said mobile phones and the learned Trial Court returned the said applications on the ground that the said Court has no jurisdiction to release the same as confiscation proceedings are initiated. He further submitted that



the petitioner is ready and willing to abide by the conditions which are going to be imposed by this Court.

4. *Per contra*, learned Additional Public Prosecutor opposed the relief sought by the learned counsel for the petitioners.

5. Having considered the rival submissions made by the respective parties and after perusal of the record, it reveals that the petitioners were arrayed as accused Nos.1 and 3 in respect of F.I.R.No.31 of 2026 of Kathlapur Police Station, Jagital District, for the offences punishable under Sections 303(2) of BNS, Section 3 of the PDPP Act, Section 21(4) of MMDAR Act and Sections 180, 181 and 184 of the MV Act. It is not in dispute that the petitioners' mobile phones were seized by SHO, Kathlapur Police Station, Jagital District, in connection with F.I.R.No.31 of 2026 on 20.02.2026. Since then, the said mobile phones are in the custody of the SHO, Kathlapur Police Station, Jagital District. The applications filed by the petitioners seeking interim custody of the mobile phones were returned as stated supra.

6. Taking into consideration the peculiar facts and circumstances of the case, this Court is inclined to grant interim custody of the petitioners' mobile phones i.e., iPhone 13 128 Gb and Redmi 6i bearing Ph.No.6281927597, respectively, subject to the condition

that the petitioners shall execute a personal bond for a sum of Rs.5,000/- (Rupees Five Thousand only) to the satisfaction of the learned Judicial Magistrate of First Class at Korutla and also on their furnishing an undertaking that they shall produce their mobile phones either before the Investigating Officer or before the Trial Court, as and when required and also file an undertaking that they shall not alienate the mobile phones in favour of any third parties till the conclusion of proceedings in F.I.R.No.31 of 2026 of Kathlapur Police Station, Jagital District.

7. Accordingly, these criminal petitions are disposed of.

Pending miscellaneous applications, if any, shall stand closed.

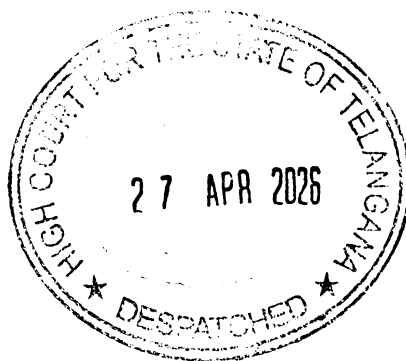
