Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any appropriate writ, order or direction, more particularly one in the nature of Writ of Mandamus,

- i. Declaring the action of the Respondents in seeking to provide online counseling and centralized process of counseling for allotment of students into the Petitioner Institutions including by issuing the Notification dated 13.04.2026 for the Academic Year 2026-27 as being wholly arbitrary, illegal and unconstitutional, apart from being without any authority of law and in violation of the mandate of the Judgments of the Honourable Supreme Court and set aside the same
- ii. Consequentially direct the Respondents not to enforce the online admission process in regard to Undergraduate Courses on the Petitioner Colleges including by not interfering with the Petitioners process of admissions into various undergraduate courses of Study for the Academic Year 2026-27.

This petition coming on for hearing, upon perusing the petition and affidavit filed in support thereof and W.P.No.12503 of 2026 upon hearing the arguments of SRI TARUN G. REDDY, counsel for the Petitioners, and of GP FOR HIGHER EDUCATION on behalf of Respondent Nos. 1,2 & 4 and of SRI A.P.SURESH RAM, SC FOR TGCHS on behalf of Respondent No.3, and of SRI M.SRINIVAS REDDY, SC FOR OU on behalf of Respondent No.5, the Court made the following: **ORDER**

For the reasons stated in the accompanying affidavit, this Interlocutory Application is allowed. Consequently, the writ petition, insofar as the petitioner Nos.8 and 9 in Writ Petition No.12503 of 2026 are concerned, is dismissed as withdrawn.

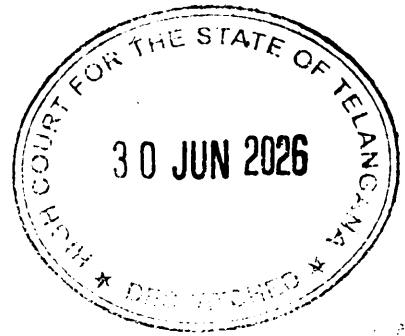
