ORDER:

This Court vide order dated 04-07-2025 directed respondent No.2 to appear before this Court, in case of non-compliance of the order dated 19-04-2023.

Mr. S. Rahul Reddy, learned Special Government Pleader, submits that Mr. E. Naveen Nicolas is holding the pose of Director of School Education, Telangana, Hyderabad. He further submits that respondent No.2 in the present Contempt Case has been transferred and posted as Commissioner, Collegiate and Technical Education, Telangana and she is having a pre-scheduled meeting with Telangana Education Commission on 18-07-2025; therefore, she could not appear before this Court.

Considering the submissions made by the learned Special Government Pleader, the appearance of the 2nd respondent is dispensed with.

Registry is directed to implead Mr. E. Naveen Nicolas, Director of School Education, Telangana, Hyderabad as party respondent in the present contempt case.

Accordingly, the Application is ordered.
