WHEREAS the Petitioner above named through his Advocate Sri A NAJEEB KHAN presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ, Order or Direction more particularly one in the nature of WRIT OF MANDAMUS declaring inaction of the Respondents No.2 and 3 in removing the encroachment made by the Respondent No.4 in front of the commercial complex of the petitioner bearing Municipal No.8-6-301, Opp: Badam Yellareddy Statue, Karimnagar Town as illegal and arbitrary

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. A NAJEEB KHAN Advocate for the Petitioner, Government Pleader for MA&UD for Respondent No.1, Sri K. Siddarth Reddy, Standing Counsel for the Municipalities for Respondent No.2 and Asst. Government Pleader for Home for Respondent No.3 directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 27.04.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the memorandum of grounds filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

The Court made the following:

ORDER

Notice before admission.

Learned Government Pleader for MA&UD takes notice on respondent No.1.

Sri.K.Siddarth Reddy, learned standing counsel for Municipality takes notice on respondent No.2.

Learned Assistant Government Pleader for Home takes notice on respondent No.3.

Learned counsel for the petitioner is permitted to take out personal notice on respondent No.4 and file proof of the same.

This writ petition is filed seeking the following prayer:-

"to declare the inaction of the Respondents Nos.2 and 3 in removing the encroachment made by the respondent No.4 in front of the commercial complex of the petitioner bearing Municipal No. 8-6-301, Opp: Badam Yellareddy Statue, Karimnagar Town, as illegal and arbitrary."

Learned counsel for the petitioner submits that due to traffic congestion, the respondent No.3 in front of the petitioner's subject property erected a board, stating *"No Stopping or Standing"*, and to support his contentions, learned counsel for the petitioner had placed on record a copy of photograph of the erected board. Learned counsel for the petitioner would further submit that inspite of the said board, the respondent No.4 had placed some bricks, stones and attempting to create a temple like structure which is not at all in existence and is trying to form an auto stand in front of the

petitioner's subject property. Hence, the petitioner on 27.11.2025 and 12.01.2026 made representations and requested respondent Nos.2 and 3 to take action.

Learned standing counsel for Municipality appearing for respondent No.2 placed on record instructions issued by the Assistant City Planner, Municipal Corporation, Karimnagar, wherein it is submitted that on petitioner's representation, the Municipal officer visited the subject site and during the course of inspection, it was observed that there is a small improvised arrangement comprising two cement bricks with a stone placed over the same symbolizing Maisamma Talli (local diety) and on further enquiry the residents have expressed that any attempt to remove the said structure may cause inconvenience and may disturb local sentiments.

In view of the above discrepancy, the respondent authorities are directed to verify whether the aforesaid structure is new or an old existing and file a report.
