Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction more particularly one in the nature of Writ of Mandamus questioning the action of the respondent authorities in trying to dispossess the petitioners from their lands to an extent of lands below Ac, 3.00 cents each in Sy. Nos. 62 and 65 compartment, and its boundaries are East. Seetha Vaagu, West. Thali Peru Kaluva, South. Seetha Vaagu and Thali Peru kaluva, North. Devarapalli and Mamidipally villages situated near Mamidigudem Village, Charla Mandal, Bhadradi Kothagudem District, inspite of the unanimously resolution passed in Grama Sabha dt.16.12.2020 under the Schedule Tribes and other, Traditional Forest Dwellers (Recognition of Forest Rights Rules, 2007) without any notice, assigning reasons as illegal, arbitrary, abuse process law and also violation of Articles 14, 19, 21 and 300-A of the Constitution of India and consequently direct the respondents not to interfere with the peaceful possession of the petitioners in the lands in question .

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondents not to dispossess the petitioners from their lands to an extent of lands below Ac. 3.00 each in Sy.Nos. 62 and 65 compartment, and its boundaries are East. Seetha Vaagu, West Thali Peru Kaluva, South, Seetha Vaagu and Thali Peru kaluva, North. Devarapalli and Mamidipally villages situated near Mamidigudem Village, Charla Mandal, Bhadradi Kothagudem District, pending disposal of WP No 16096 of 2021, on the file of the High Court.

The petition coming on for hearing, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of SRI KONDAPARTHI SRINIVASA Advocate for the Petitioners, GP FOR FORESTS (tg) for the Respondents, the Court made the following.

ORDER

Heard Sri Kondaparthi Srinivasa, learned counsel appearing on behalf of the petitioners.

Learned Government Pleader for Forests appearing on behalf of the respondents is present.

Status quo shall be maintained in respect of the lands to an extent of lands below Ac.3.00 cents each in Sy. Nos. 62 and 65, compartment and its boundaries, namely, East – Seetha Vaagu; West – Thali Peru Kaluva, South – Seetha Vaagu and Thali Peru Kaluva, and North – Devarapalli and Mamidipally villages, situated near Mamidigudem Village, Charla Mandal, Bhadradi Kothagudem District, till 17.06.2026.
