WHEREAS the Petitioner above named through his Advocate Sri NAGESHWAR RAO PUJARI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ, Order or Direction more particularly one in the nature of Writ of Mandamus questioning the action of the respondent No.3 in withholding the custody of the original educational certificates of Secondary School Certificate (SSC), Intermediate Pass Certificate-cum-Memorandum of Marks, Transfer Certificate of Intermediate Course (TC), and Bonafide certificates of the petitioner as illegal, arbitrary, and unconstitutional and subsequently direct the respondent no.3 college to release the original educational certificates of Secondary School Certificate (SSC), Intermediate Pass Pass Certificate-cum-Memorandum of Marks, Transfer Certificate of Intermediate Course (TC), and Bonafide certificates of the petitioner.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. NAGESHWAR RAO PUJARI Advocate for the Petitioner, Mr. M.Vamshi Kiran, Assistant Government Pleader for Higher Education for respondent No.1, and Mr. Prabhakar Peri, Standing Counsel for JNTU for respondent No.2, directed issue

of notice to the Respondent No.3 herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 04.05.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.
