No.10-1- 1 / 61/

144EP admeasuring 65 Sq. Yards as arbitrary, illegal, and violative of the Petitioner's rights b) Consequently, directing the Respondent Nos. 3 to consider the Petitioner's representation dated 19.12.2025 and to implement the Speaking Order dated 23.02.2026 by demolishing the illegal/unauthorized construction forthwith.
