The presence of the petitioners/respondents in D.V.C.No.194 of 2024 on the file of the IV Metropolitan Magistrate, Integrated Family Court Complex, Kalpataru, at Hyderabad, is dispensed with, subject to the condition that they shall be represented through their counsel on each and every date of hearing. If the presence of the petitioners/respondents is required, they shall appear before the trial Court. In case of non-appearance on the specific date fixed by the trial Court for their appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
