AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri B.SHIVA KUMAR, Advocate for the Petitioner, PUBLIC PROSECUTOR for the respondent No.1, directed issue of notice to the Respondent No.1, herein to show cause as to why this CRIMINAL PETITION should not be admitted.

Petition under Section 528 of B.N.S.S. praying that in the circumstances stated in the grounds filed in support of the CRIMINAL PETITION, the High Court may be to stay all further proceedings including appearance of the Petitioner/Accused No.8 in CC No. 492 of 2024 on the file of XIV Metropolitan Magistrate Cyberabad at Hayathnagar, pending disposal of CRLP No.6113 of 2026, on the file of the High Court.

ORDER:

Notice before admission.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.2 by way of Speed Post with Acknowledgment Due and file proof of service.

Post on 02.07.2026.

Upon perusal of the record, it reveals that on 26.04.2024, the learned Magistrate has taken cognizance, without recording his satisfaction and without assigning any reasons and issued summons, which is contrary to the principles laid down by the Hon'ble Apex Court in *Sunil Bharati Mittal v. Central Bureau of Investigation*¹ and *Fakhruddin Ahmad v. State of Uttaranchal and another*².

In view of the above, the presence of the petitioner/accused No.8 in C.C.No.492 of 2024 on the file of the XIV Metropolitan Magistrate, Cyberabad at Hayathnagar, is dispensed with, subject to the condition that he shall be represented through his counsel on each and every date of

hearing. If the presence of the petitioner/accused No.8 is required, he shall appear before the trial Court. In case of non-appearance on the specific date fixed by the trial Court for his appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
