WHEREAS the Petitioners above named through their Advocate SRI NANDIGAM KRISHNA RAO presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of Writ of Mandamus i) to declare the inaction on the part of the third and fourth respondents in not reinstating back in to service the first petitioner as Assistant Professor and the second petitioner as Associate Professor in Mechanical Engineering Department, in compliance of the orders passed by the respondent No.2 dated 21/1/2019 in file No.CTE-ACD1/EPA/1/2018-ACADEMIC-1 by paying arrears of salary due for May, June and from 07/07/2017 onwards and by paying all service benefits to the petitioners from the date of termination order as illegal, arbitrary, unjust and unconstitutional apart from violation of principles of natural justice and contrary to the orders passed by the second respondent in File No.CTE-ACD1/EPA/1/2018-ACADEMIC-1 dated 21/1/2019 and mandatory provisions of under Sec.28 of the Telangana Education Act and ii) to consequently declare the inaction on the part of the first and second respondents in not taking any action as against the third and fourth respondents for non-compliance of the orders passed by the second respondent in File No. CTE-ACD1/ EPA/1/ 2018-ACADEMIC-I dated 21/1/2019, in refusing to take the petitioners back in to service, in terms of sec.84A and 24 of the Telangana Education Act,;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri NANDIGAM KRISHNA RAO Advocate for the Petitioners, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
