WHEREAS the Petitioner above named through his Advocate SRI SYED NAJMUL HASSAN BAQRI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly a Writ of Mandamus, directing Respondent Nos. 2 to 6 to forthwith consider and expeditiously dispose of the Petitioner's application dated 15.02.2026 in accordance with law. It is further prayed that Respondent Nos. 2 and 6 be directed to initiate appropriate demolition proceedings against the unauthorized constructions raised by Respondent No. 7, strictly in accordance with the provisions of Sections 428, 452, 220-A and 461 of the Greater Hyderabad Municipal Corporation Act, 1955,

as the said constructions are in clear violation of statutory provisions and established legal norms.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI. SYED NAJMUL HASSAN BAQRI Advocate for the Petitioner, Government Pleader for MA&UD for respondent No.1 and Sri.R.Venkatesh, standing counsel for GHMC for respondent Nos.2 to 6, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
