WHEREAS the Petitioner above named through his Advocate Smt. V POORNASRI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction more particularly one in the nature of Writ of Mandamus, declaring the action of the Respondent No.5 in trying to deducting the Petitioner's Salary in pursuance to the Order passed in E.P.No.143 of 2023 in A.R.B No. 46 of 2021, Dt 19-12-2025 on the file of the Court of the Principal Junior Civil Judge at Sangareddy vide Award passed in A.R.B No. 46 of 2021, Dt 06.06.2022 as illegal and arbitrary and also bad in law and consequently issue a



direction, directing the 5th Respondent herein not to take any coercive/deduction of salary of the Petitioner in pursuance to the Order passed in E.P.No.143 of 2023 in A.R.B No. 46 of 2021, Dt 19.12.2025, on the file of the Court of the Principal Junior Civil Judge at Sangareddy vide Award passed in A.R.B No. 46 of 2021, Dt 06-06-2022.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. V POORNASRI Advocate for the Petitioner and Government Pleader for Stamps & Registration directed issue of notice to the Respondent Nos.4 to 6 to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 15.07.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

I.A. NO: 1 OF 2026

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant interim stay of all further proceedings in pursuance to the Order passed in E.P.No.143 of 2023 in A.R.B.No.46 of 2021, dated 19-12-2025 on the file of the Court of the Principal Junior Civil Judge at Sangareddy vide Award passed in A.R.B.No.46 of 2021, dated 06.06.2022 including disbursement of Petitioners salary, pending disposal of WP No 12689 of 2026, on the file of the High Court.

The Court made the following:

ORDER

Notice before admission.

Learned Government Pleader for Revenue General (Stamps and Registration) takes notice on behalf of respondent Nos.1 to 3, waives further notice and seeks time to file counter.

Registry is directed not to take out notice to respondent Nos.1 to 3 in view of the above waiver.

The learned counsel for the petitioner is permitted to take out personal notice to respondent Nos.4 to 6 and to file proof of service in the registry.

The learned counsel for the petitioner submits in *Punyamurthula Venkata Viswa Sundara Rao v. Margadarsi Chit Fund Private Limited, Hyderabad and others* [2017(3) ALD 387], the Division Bench of this Court held that the E.P. Court does not have jurisdiction to entertain an application for execution of the award passed by the Deputy Registrar of Chit Funds, if presented by the decree holder. However, in the instant case also, straightaway E.P.No.143 of 2023 in Arb.No.46 of 2021 was filed before the Principal Junior Civil Judge, Sangareddy, against the petitioner and others, without it being presented/forwarded by the Registrar. In view of the decision referred to above, balance of convenience is in favour of the petitioner.

Hence, there shall be interim stay as prayed for insofar as petitioner is concerned.
