In view of the same, the Assistant Town Planner, GHMC, Circle No.6, Sardar Mahal, Hyderabad, the 2nd respondent, is directed to verify the genuineness of the claim made by the petitioners and if necessary conduct physical inspection of the subject property to know as to whether any illegal construction is made by the unofficial respondents and take appropriate action as warranted by law on the representation made by the petitioners. Such exercise shall be completed within a period of six weeks from the date of receipt of a copy of this order.
