WHEREAS the Petitioner above named through her Advocate SRI Y ASHOK RAJ presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction, more particularly one in the nature of WRIT OF MANDAMUS to declare the action of the official respondents in entering the name of the unofficial respondent in the revenue records against the lands of the petitioner in Sy.No.1032/39 admeasuring Ac.1.00 gts situated at Kalva Village, Dilawarpur Mandal, Nirmal District without issuing any notice, without following due process of law and without giving any opportunity, as illegal, arbitrary and violation of Telangana Assigned Lands (Prohibition of Transfers) Act, 1977 and against to the principles of natural justice and violation of Articles 14, 19, 21 and 300-A of the Constitution of India and consequently direct the official respondents to mutate the name of the petitioner in the revenue records against the above subject land by removing / deleting the name of the unofficial respondent.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. Y ASHOK RAJ Advocate for the Petitioner, GP FOR REVENUE, for the respondent Nos. 1 to 4, directed issue of notice to the Respondent No.5, herein to show cause as to why this WRIT PETITION should not be admitted.

***Status quo*, obtaining as on today, shall be maintained with regard to revenue entries in respect of the land admeasuring Ac.1-00 guntas in Survey No.1032/39 situated at Kalva Village, Dilawarpur Mandal, Nirmal District, till the next date of hearing.**
