Mts., in Sy.nos.218, and 219, situated at Sri Chakripuram, Kushaiguda, Kapra within the limits of GHMC, Kapra Circle and Mandal, Medchal-Malkajgiri District, without assigning any reason as being illegal, arbitrary and without jurisdiction and against to the provisions of law and contrary rights guaranteed under 300-A of Constitutional of India and consequently direct the 2nd Respondent to receive, register and release the documents presented by the Petitioner in respect of Open Plot bearing no. 75, admeasuring 301.00 Sq.Yards or 251.63 Sq. Mts., in Sy.nos.218, and 219, situated at sri KaprChakripuram, Kushaiguda, Kapra within the limits of GHMC, Kapra Circle and Mandal, Medchal-Malkajgiri District.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri D BHASKAR YADAV Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
