WHEREAS the Petitioner above named through her Advocate Sri. PENUBALLI RAMESH BABU presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ, direction or order more particularly one in nature of writ of mandamus declaring the action of Respondents in not considering the objections dated 07-04-2026 of the Petitioner and trying to release compensation in favour of the Respondent No.6 in connection to the land to an extent of Ac.5-00 gts in Lemoor Village, Kandukur Mandal, Rangareddy District as illegal, void and violative of Article 14, 16, 21 and 300-A of Constitution of India and consequently direct the Respondent No.1 to 5 not to pay the compensation amount to the Respondent No.6 without considering the objections dated 07-04-2026 of the Petitioner in the interest of justice,

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. PENUBALLI RAMESH BABU Advocate for the Petitioner, directed issue of notice to the Respondent No.6 herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 08.06.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

I.A. NO: 1 OF 2026

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondent No.1 to 5 not to pay the compensation amount to the Respondent No.6 without considering the objections dated 07-04-2026 of the Petitioner in connection to the land to an extent of Ac.5-00 gts in Lemoor Village, Kandukur Mandal, Rangareddy District Pending disposal of WP No 12809 of 2026, on the file of the High Court.

ORDER

Learned Government Pleader for Land Acquisition takes notice on behalf of the respondents No.1 to 5 and seeks time to get instructions in the matter.

Issue notice to respondent No.6.

Learned counsel for the petitioner is permitted to take out personal notice on the respondent No.6 and file proof of the same.

Learned counsel for the petitioner would submit that the respondents, without considering the representation dated 07.04.2026 made by the petitioner, are trying to release the compensation in favour of the respondent No.6 in connection to the land to an extent of Acs.5.00 guntas in Lemoor village, Kandukur Mandal, Rangareddy district.

The Registry is directed to list the matter on 08.06.2026.

In the meanwhile, the respondents shall examine the representation dated 07.04.2026, stated to have been made by the petitioner.
