WHEREAS the Petitioner above named through his Advocate SRI MOHAMMED MUDABBIR ALI KHAN presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, order or direction more particularly one in the nature of Mandamus declaring the action of the respondents in interfering with the petitioner's property admeasuring Ac.0.1000gts bearing sy.no. 488/A/2 Ameerguda Village, Moinabad Mandal and Ranga Reddy District at the instance of the unofficial respondent without issuing any notice or intimation and the same is illegal, arbitrary, violative of Article 21 and 300A of the Constitution of India and consequently to direct the respondents to not to interfere in the petitioner's peaceful possession and enjoyment of the subject land without following due process of law.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI MOHAMMED MUDABBIR ALI KHAN Advocate for the Petitioner and GP FOR REVENUE appearing for the Respondents no. 1 to 4 directed

issue of notice to the Respondent no. 5 herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 12.06.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondent authorities to not to interfere into the petitioner's property admeasuring Ac.0.1000gts bearing sy.no. 488/A/2 Ameerguda Village, Moinabad Mandal and Ranga Reddy District, pending disposal of WP No 12968 of 2026, on the file of the High Court.

The Court made the following

ORDER:

Issue notice to respondent No.5.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.5 and file proof of service by the next date of hearing.

The petitioner claims to be the owner and possessor of the land admeasuring Ac.0-10 guntas in Survey No.488/A, situated at Ameerguda Village, Mouinabad Mandal, Ranga Reddy District, having purchased the same under registered sale deed bearing document No.687 of 2026 dated 28.03.2026. It is alleged that at the instance of respondent No.5, respondent No.4 is interfering with the possession of the petitioner in respect of the subject property.

The contents of the sale deed reveal that the vendor of the petitioner was issued pattadar pass book bearing document No.T05180300753.

Prima facie, the petitioner appears to be the owner and possessor of the subject land.

Hence, there shall be interim direction to the respondent authorities not to interfere with the possession of the petitioner in respect of the subject land without following due process of law.
