Learned Additional Public Prosecutor takes notice on behalf of respondent No.1.

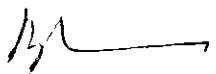

In case of his non-appearance on the specific date fixed by the trial Court for his appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
