Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus declaring the action of the Respondents, more particularly Respondent Nos.4 and 5 in interfering with the lawful 60 years of physical possession and enjoyment of the petitioners property and trying to dispossess them from the possession of their property over the land i.e., to an extent of Acres.7-28 Guntas in Survey Nos.318, 319 and 646 situated at Jawahar Nagar Village, Kapra Mandal, Medchal-Malkajgiri District, Telangana which has standing crops as being illegal, arbitrary, without jurisdiction and violative of Articles 14, 21 and 300 A of the Constitution of India, and consequently direct the Respondents not to interfere with the peaceful and uninterrupted possession of the petitioners and dispossess them from the subject land admeasuring Acres.7-28 Guntas in Survey Nos.318, 319 and 646 situated at Jawahar Nagar Village, Kapra Mandal, Medchal-Malkajgiri District which has standing crops.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondents not to interfere with the lawful peaceful and uninterrupted possession of the Petitioners and dispossess them from the subject land admeasuring Acres.7-28 Guntas in Survey Nos.318, 319 and 646 situated at Jawahar Nagar Village, Kapra Mandal, Medchal-Malkajgiri District which has standing crops, pending disposal of WP No 12613 of 2026, on the file of the High Court.
