Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondent No.3 to act upon the representation made by the petitioner dated 04-04-2019 and 10-06-2019 by demolishing the unauthorized construction of compound wall constructed by the 4th respondent on the house site of the petitioner Sy.No.314/A to an extent of 160 Sq. Yards situated at Fort Warangal Road, Fort Warangal Village, Warangal City and District, pending disposal of the Writ Petition No.14149 of 2019, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following (The receipt of this order will be deemed to be the receipt of notice in the case)

ORDER:

The grievance of the petitioner is against construction of compound wall by the 4th respondent.

On instructions, learned Standing Counsel informs the Court that on 07.06.2019 notice under Section 452 (2) of Greater Hyderabad Municipal Corporation Act (for short 'the GHMC Act') and on 07.07.2019 notice under Section 452 (1) of the GHMC Act, was issued to the 4th respondent and further action is being taken.

In view thereof, 4th respondent is directed not to make any further construction of compound wall and the 3rd respondent is directed to ensure that no further construction is made by the 4th respondent.
