Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction, more particularly one in the nature of Writ of Mandamus.

a. declaration and challenging the action of the Respondents no.3-4 in interfering into peaceful possession and enjoyment of petitioner's agricultural land total admeasuring Ac.5.17 gts in Sy. No.318/AA, 318/E, 318/U, 318/K, 318/R for the purpose of conducting fresh or resurvey behest the back of vested interested persons despite of survey concluded by Panchanama and fixing boundaries long back of 2 years, 4 months (849 days) i.e., on 20-12-2023, as per the directions in W.P no. 23696 of 2021, dt.29-09-2021 and Appl. No. DER022000560006, dt. 05-10-2020, as being illegal, arbitrary and unconstitutional and in violation of provisions of Telangana Survey and Boundaries Act 1923.

b. Consequently, direct the Respondents no.2-4, not to interfere in any manner including entry into petitioner's agricultural land admeasuring total Ac. 5-17

guntas, in Sy. No.318/AA (Ac. 0-25), Sy. No.318/E (Ac. 2-22), Sy. No.318/U (Ac. 1-17), Sy.No.318/K (Ac. 0-11), Sy. No.318/R (Ac.0-22), situated at Kasala Village Shivar, Hathnoora Mandal, Sangareddy District, for the purpose of fresh or resurvey and in any other way without following due process of law in the interest of justice;

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to pass an interim measure, direct the Respondents No.2 to 4 not to interfere in any manner including entry into petitioner's agricultural land admeasuring total Ac. 5-17 guntas, in Sy No.318/AA (Ac. 0-25), Sy. No.318/E (Ac. 2-22), Sy. No.318/U (Ac. 1-17), Sy.No.318/K (Ac. 0-11), Sy. No.318/R (Ac.0-22), situated at Kasala Village Shivar, Hathnoora Mandal, Sangareddy District, for the purpose of fresh or resurvey and in any other way without following due process of law in the interest of justice., pending disposal of WP No 12770 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri. SUDARSHAN MALUGARI Advocate for the Petitioner, SRI L. RAVINDER, AGP FOR REVENUE for respondent Nos. 1 to 3, the Court made the following:

ORDER

The petitioner claims to be the pattadar and possessor of the land admeasuring Acs.5-17 guntas in Survey Nos.318/AA, 318/E, 318/U, 318/K, 318/R, situated at Kasala Village Shivar, Hathnoor Mandal, Sanga Reddy District, on the strength of e-pattadar pass book No.T09040120745 with Khata No.1057. It is alleged that respondents No.3 and 4 are trying to interfere with the possession of the petitioner in respect of the subject land. Respondent No.4 is a Mandal Surveyor and without any application being filed by the petitioner or third party, there is interference by respondent No.4, as such, he is made party in personal capacity.

Mr. L.Ravinder, learned Assistant Government Pleader for Revenue, appearing for the respondents, takes preliminary objection to the arraignment of respondent No.4. It is submitted that respondent No.4 is Mandal Surveyor and he is performing his official duties.

In the circumstances, respondent No.4 is deleted from the array of parties.

There shall be interim direction to the respondent authorities not to interfere with the possession of the petitioner in respect of the subject land without following due process of law.
