Srinivas Polavarapu presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction more particularly one in the nature of Writ of Mandamus declaring the action of Respondent No.2 in issuing a fresh Tender Notification No. PDS2/Movt./FG5(1)/Stage-I tenders/2026-28/TS dated 17-04-2026 published in the Eenadu Daily Newspaper dated 18-04-2026 in so far as Hyderabad and Sangareddy district concerned as well as trying to Award Contract in favour of Sri Srinivasa Transport Contractors in respect of Siddipet District in pursuance to the Tender Notification dated 25-02-2026 be declared illegal and arbitrary, violative of Article 14, 19 and 300-A of the Constitution of India and consequently direct Respondent No.2 to consider and finalize the Tender in favour of Petitioner Firm in respect of Hyderabad, Sangareddy, Siddipet District Concerned in pursuance to Tender Notification dated 25-02-2026;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. Srinivas Polavarapu Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

In so far as Siddipet District is concerned, the award of any contract in pursuance to the tender notification dated 25.02.2026 shall be subject to the final outcome of the present writ petition
