WHEREAS the Petitioner above named through their Advocate Sri Mirza Shah Nawaz Baig presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of "Writ of Mandamus" by declaring the action of the Respondent No.5 in interfering into the life and liberty of the petitioners at the instance of Respondent No.6 & 7 and pressurizing the petitioners to compromise with Respondent No.6 and 7 and also pressuring the petitioner to withdraw O.S.No.473/2019 on the file of XVIII Senior Civil Judge, City Civil Court at Hyderabad and CMA No.46/2024 on the file of XXVI Additional Chief Judge, City Civil Court at Hyderabad, filed by me, as arbitrary, ex-facie illegal, highhanded, dereliction of duty and discriminatory and consequently

direct the Respondents No.5 not to interfere into the civil disputes between the petitioners and the Respondent No. 6 & 7, in respect of premises property bearing Municipal No.19-4-6/A/9, admeasuring 1620 square yards, situated at Falaknuma Palace Road, Chandrayangutta, Hyderabad, T.S., as well as not to call the Petitioners to the police station.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri Mirza Shah Nawaz Baig, Advocate for the Petitioner, GP FOR HOME, for the Respondent Nos.1 to 5 directed issue of notice to the Respondent Nos.6 & 7 herein to show cause as to why this WRIT PETITION should not be admitted.

Learned counsel for the petitioners is permitted to take out personal notice to respondent Nos.6 and 7 under the registered post with acknowledgement due and file proof of service by the next date of hearing.

Respondent No.5 - the Station House Officer, Bandlaguda, Hyderabad, is directed not to interfere in civil disputes between the petitioner and respondent Nos.6 and 7 in respect of the property bearing Municipal No.19-4-

6/A/9, admeasuring 1620 square yards, situated at Falaknuma Palace Road, Chandrayangutta, Hyderabad, without following due process of law.
