AKKAM ESHWAR presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the action of the 4th Respondent in issuing Impugned Endorsement dated 15.04.2022 vide Lr.No.B/263/2023, rejecting the request of the Petitioner to rectify the revenue entries to an extent of Ac.0-10 gts in Sy.No.277, situated at Sultan Nagar, Banjepalle Revenue Village, Nizam Sagar Mandal, Kamareddy District, and to restore the same in favour of the Petitioners, as

illegal, arbitrary and against the new ROR Act, 2025, in violation of principles of natural justice and also against all settled principles of law and set-aside the same and consequently direct the Respondents to consider the Bhu-Bharati Application No.12252150230032 for rectification of revenue entries in respect of the Petitioners agricultural land to an extent of Ac.0-10 gts in Sy.No.277, situated at Sultan Nagar, Banjepalle Revenue Village, Nizam Sagar Mandal, Kamareddy District and restore the same in favour of the Petitioners,
