The presence of the petitioner/accused No.14 in C.C.No.9214 of 2024 on the file of the XII Additional Chief Metropolitan Magistrate, Nampally, Hyderabad, is dispensed with, subject to the condition that she shall be represented through her counsel on each and every date of hearing. If the presence of the petitioner/accused No.14 is required, she shall appear before the trial Court. In case of non-appearance on the specific date fixed by the trial Court for her

appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
