WHEREAS the Petitioner above named through their Advocate SRI KARTHIK MADHANU presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any order, direction or writ, more particularly in the nature of Writ of Mandamus declaring the inaction of the Respondents more particularly Respondent No. 3 in not disposing of the 1st Petitioner's application dt 17.11.2025, 24.04.2013, 20.05.2009, 22.07.2008 and 25.10.2007 seeking to cancel or revise the layout vide DP. No. 64/2009 in File No. C2/1615/2006/3539, dt 26.12.2009, forwarded by the Respondent No. 2 vide Lr.Roc. No. E-124508/HO/2026, dt 12.02.2026 as being illegal, arbitrary, apart from being violative of articles 14, 21 and 300A of the Constitution of India, 1950 and consequently, direct the Respondent No.3 herein to dispose of the Petitioner's application dt

17.11.2025 seeking to cancel or revise the layout vide DP. No. 64/2009 in File No. C2/1615/2006/3539, dt 26.12.2009, forwarded by the Respondent No. 2 vide Lr.Roc. No. E-124508/HO/2026, dt 12.02.2026 at the earliest possible.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI. KARTHIK MADHANU Advocate for the Petitioner, Government Pleader for Municipal Administration and Urban Development for respondent No.1, Sri Pasham Mohith, Standing Counsel for Greater Warangal Municipal Corporation for respondent No.2 and Standing Counsel for Kakatiya Urban Development Authority for respondent No.3, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
