Learned counsel for the petitioner would submit that, respondent No.2 <i>vide</i> Proceedings in Rc.No.W12/1942/2025, dated – nil-01.2026, directed respondent No.3 to take immediate necessary action for execution of works in the adjacent land of the petitioner as per the guidelines of MGNREGS. Learned counsel for the petitioner would further submit that, on the pretext of execution of the said works, the petitioner is apprehending an intrusion into the possession of his land for construction of Self Help Groups (SHG) Federation buildings for groups. In this regard, the petitioner made a representation, dated 13.04.2026 to the respondents herein. The grievance of the petitioner is that, even after receipt of the said representation, the respondents did not consider the same and if any action would be taken by the respondents, he will be deprived of his valuable property. The said aspects require detailed examination and the facts can only be ascertained after filing detailed counter by the respondents.
