Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of Writ of Mandamus by declaring the action of Respondents herein in interfering with the peaceful possession and enjoyment of the petitioners land in Edulaguttapally Village, Manakondur Mandal, Karimnagar District in pursuance of the proceedings issued by the Respondent No. 2 vide proceedings No.RC.No.W12/1942/2025 and threatening to dispossess him from his property as arbitrary illegal void ab initio besides in violation of principles of natural justice besides in violation of Article 300-A of constitution of India and further may be pleased to direct the Respondents herein or their subordinates not to interfere and not to dispossess the petitioner from said abadi land to an extent of Ac1.04Gts in Edulaguttapally Village, Manakondur Mandal, Karimnagar District in pursuance of the proceedings issued by the Respondent No. 2 vide proceedings No.RC.No.W12/1942/2025 without following due process of law.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondents herein or their subordinates not to interfere and not to dispossess the petitioner from said abadi land to an extent of Ac1.04Gts in Edulaguttapaly Village, Manakondur Mandal, Karimnagar District in pursuance of the proceedings issued by the Respondent No. 2 vide proceedings No.RC.No.W12/1942/2025 without following due process of law, pending disposal of WP No 12919 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of SRI KALIDAS VAMSHIKRISHNA Advocate for the Petitioner, SRI P. ASHOK KUMAR, AGP FOR PANCHAYAT RAJ RURAL DEVELOPMENT appearing for the Respondents no. 1, 3, 4 and 6, SRI K. MAHESH, AGP FOR REVENUE, appearing for the Respondents no. 2 and 5 and SRI RAMAKRISHNA REDDY, COUNSEL REPRESENTING SRI KATTA PRADEEP REDDY Standing Counsel appearing for the Respondent no.7, the Court made the following.

ORDER:

Notice before admission.

Sri P. Ashok Kumar, learned Assistant Government Pleader for Panchayatraj, takes notice for respondent Nos.1, 3, 4 and 6, waives further notice and seeks time to get instructions.

Sri K. Mahesh, learned Assistant Government Pleader for Revenue, takes notice for respondent Nos.2 and 5, waives further notice and seeks time to get instructions.

Sri Ramakrishna Reddy, learned counsel representing Sri Katta Pradeep Reddy, learned Standing Counsel, takes notice for respondent No.7, waives further notice and seeks time to get instructions.

Learned counsel for the petitioner would submit that the father of the petitioner, by name Meesa Narayana, was the owner and possessor of the land admeasuring Ac.0.27 guntas situated in Sy.No.214/అ/1; Ac.0.23 guntas in Sy.No.215/అ; Ac.0.23 guntas in Sy.No.216/అ; Ac.0.06 guntas in Sy.No.217/అ; Ac.0.06 guntas in Sy.No.217/అ; Ac.0.06 guntas in Sy.No.217/అ; Ac.0.05 guntas in Sy.No.217/అ; Ac.0.05 guntas in Sy.No.217/అ; Ac.0.05 gts. in Sy.No.217/అ; Ac.0.05 guntas in Sy.No.217/అ; Ac.0.13 guntas in Sy.No.218/అ; Ac.0.02 gts. in Sy.No.219/అ; Ac.0.15 gts. in Sy.No.219/అ; and Ac.0.14 gts. in Sy.No.219/అ of Eedulagattipalli Village, Manakondur Mandal, Karimnagar District and his name was incorporated in the revenue records and he was also issued patta lar passbook bearing No.T17110130039 vide Khata No.86 and the petitioner is in possession of the adjacent abadi land and used the same for cattle agricultural necessities. Learned counsel for the

petitioner would submit that, respondent No.2 *vide* Proceedings in Rc.No.W12/1942/2025, dated -nil-01.2026, directed respondent No.3 to take immediate necessary action for execution of works in the adjacent land of the petitioner as per the guidelines of MGNREGS. Learned counsel for the petitioner would further submit that, on the pretext of execution of the said works, the petitioner is apprehending an intrusion into the possession of his land for construction of Self Help Groups (SHG) Federation buildings for groups. In this regard, the petitioner made a representation, dated 13.04.2026 to the respondents herein. The grievance of the petitioner is that, even after receipt of the said representation, the respondents did not consider the same and if any action would be taken by the respondents, he will be deprived of his valuable property.

The said aspects require detailed examination and the facts can only be ascertained after filing detailed counter by the respondents.

In the meantime, as an interim measure, there shall be interim direction to respondent No.2 to consider the case of the petitioner and take appropriate action on the petitioner's representation, dated 13.04.2026, in accordance with law.
