Learned counsel for the petitioners is permitted to take out personal notice to respondent No.2 by way of Speed Post with Acknowledgment Due and file proof of service.

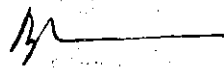
Post on 02.07.2026.

If the presence of the petitioner Nos.2 to 4/accused Nos.2 to 4 is required, they shall appear before the trial Court. In case of their non-appearance on the specific date fixed by the trial Court for their appearance, the trial Court is entitled to proceed with the matter, in accordance with law.

No such relief is granted against petitioner No.1/accused No.1.
