WHEREAS the Petitioner above named through their Advocate SRI CH. RAVI KUMAR presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction more particularly one in the nature of Mandamus, declaring the action of the respondent authorities, in recommending to appoint the 8th respondent society for de-siltation of sand to an extent of 17,00,000 CBM at K.Kondapuram sand reach of Kotha Kondapuram village, Manuguru mandal, Bhadradri Kothegudem District, even when enquiry against the said society is pending and the orders of this Hon'ble Court for appropriate action are staring at them, as illegal, arbitrary and unconstitutional and consequently set aside the proceeding dt.03.11.2025 issued by the 06th respondent recommending the allotment of excavation of sand over an extent of 17,00,000 CBM at K. Kondapuram sand reach of Kotha Kondapuram village, Manuguru mandal, Bhadradri Kothegudem District, to the 8th respondent society.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI CH. RAVI KUMAR Advocate for the Petitioners, GP FOR MINES AND GEOLOGY appearing for the Respondent no.1, GP FOR COOPERATION appearing for the Respondent no.3, SRI MUMMANENI SRINIVASA RAO Standing Counsel for TSMDC appearing for the Respondents no. 2, 5 and 6 and SRI P. KRISHNA REDDY Standing Counsel for MUNICIPALITY appearing for the Respondent no.7 directed issue of notice to the Respondent no.8 herein to show cause as to why this WRIT PETITION should not be admitted.
