AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri A. Venkatesh, Senior Counsel appearing for M/s. G SINDHU Advocate for the Petitioner, Sri G.ARUN, Advocate for the respondent, directed issue of notice to the Respondent, herein to show cause as to why this CIVIL REVISION PETITION should not be admitted.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant stay of all further proceedings in O.S.No.507/2016 on the file of II Additional District Judge, Ranga Reddy District at L.B.Nagar, pending disposal of CRP No 1229 of 2026, on the file of the High Court.

**The Court made the following:**

**ORDER:**

**Issue notice, including personal notice, to the respondent/plaintiff.**

**Learned Senior Counsel has made arguments in relation to the impugned order dated 18.03.2026 whereby an application (I.A.No.1021 of 2023 in O.S.No.507 of 2016) filed by the plaintiff was allowed with costs by the Trial Court.**

**The plaintiff filed an application under section 65 of The Indian Evidence Act, 1872 (corresponding to section 60 of The Bharatiya Sakshya Adhiniyam, 2023) for leading secondary evidence in respect of 8 documents which form part of the I.A.**

**Senior Counsel has argued that the Trial Court while passing of the impugned order failed to consider or satisfy the requisite conditions stipulated under section 65, specifically clauses (a) and (b) of The Indian Evidence Act, 1872.**

**Senior Counsel does not seek for stay of the further proceedings in the Suit.**

**Considering the submissions made and until disposal of the present Civil Revision Petition, the Trial Court shall hence proceed with the Suit.**

However, the marking of the list of documents annexed to the respondent/plaintiff's I.A. shall be subject to the result of the Civil Revision Petition.
