B.L KANAKA VALLI presented this Petition under Section 528 of B.N.S.S. praying that in the circumstances stated in the grounds filed in support of the CRIMINAL PETITION, the High Court may be pleased to quash the proceedings in M.C. No. 334 of 2023 on the file of the Judge, Integrated Courts on Family Disputes at Purana Haveli, Hyderabad.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Smt. B.L KANAKA VALLI Advocate for the Petitioner, PUBLIC PROSECUTOR for the respondent No.1 directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

are directed to show cause on or before 06.07.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the memorandum of grounds filed therewith (copy enclosed) this CRIMINAL PETITION should not be admitted.

I.A. NO: 2 OF 2026

Petition under Section 528 of B.N.S.S. praying that in the circumstances stated in the grounds filed in support of the CRIMINAL PETITION, the High Court may be pleased to stay all further proceedings in M.C. No. 334 of 2023 on the file of the Judge, Integrated Courts on Family Disputes at Purana Haveli, Hyderabad, pending disposal of the above Criminal Petition.

The Court made the following:

ORDER

Ms. B.L.Kanakavalli, learned counsel for the petitioner submits that the respondent No.2 herself filed M.C.No.9 of 2012 on the file of Additional Judicial First Class Magistrate at Siddipet, claiming maintenance for herself and her minor daughter and minor son. During the pendency of the said M.C., respondent No.2 and petitioner have entered into compromise, and the matter was referred to Lok Adalat and passed Award dated 04.02.2012 and he had paid an amount of Rs.15,00,000/- towards full and final settlement.

It is further submitted that respondent No.2, suppressing the factum of the above said facts, including Lok Adalat Award, filed the present M.C.No.334 of 2023 claiming maintenance and the same is a clear abuse of process of law.

Taking into consideration the above said submissions, this Court is of the view that the grounds, which were raised by the learned counsel for the petitioner, requires detailed examination.

Notice before admission.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.2 and also on the learned counsel appearing on behalf of respondent No.2 before the trial Court, by way of speed post with acknowledgment due and file proof of service.

Post on 06.07.2026.

Till such time, there shall be an interim stay of all further proceedings against the petitioners/respondent in M.C.No.334 of 2023 on

the file of the II Additional Family Court Judge, Integrated Courts on Family Disputes at Purani Haveli, Hyderabad.

In default of filing proof of service by the next date of hearing, the interim stay granted shall stand vacated.
