WHEREAS the Petitioner above named through his Advocate SRI JALIB HASAN presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the acts of Respondent No. 3 - Mailardevpally Police Station in repeatedly calling the Petitioner to the police station, using abusive language, and coercing him for settlement as illegal, arbitrary, and without authority of law consequently direct the Respondent No. 3 and its officials not to harass, threaten, or intimidate the Petitioner in any manner and to strictly act in accordance with law.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI JALIB HASAN Advocate for the Petitioner and AGP FOR HOME appearing for the Respondents no. 1 to 3 directed issue of notice to the Respondent no.4 herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 03.07.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondent No. 3 and its officials not to harass, threaten, or intimidate the Petitioner in any manner and to strictly act in accordance with law, pending disposal of WP No 13025 of 2026, on the file of the High Court.

The Court made the following

ORDER:

Notice before admission.

Learned Assistant Government Pleader for Home takes notice on behalf of respondent Nos.1 to 3 and waives further notice and seeks time to obtain instructions.

Issue notice to respondent No.4.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.4 by way of SPAD and file proof of service.

Since it has been submitted by learned counsel for the petitioner that without there being any registration of crime, the petitioner has been called to the police station by respondent No.3 without following due process of law, thereby interfering into the personal life and liberty of the petitioner herein.

This matter required detailed examination and the facts can be determined only upon filing of counter by the official respondents.

In the meantime, as an interim measure, respondent No.3 is directed not to interfere with the personal life and liberty of the petitioner, except under due process of law.
