K JAGADISHWAR REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue appropriate writ order or direction more particularly one in the nature of writ of mandamus or any other appropriate writ declaring award No.B/375/2024, dt.10-07-2025 passed by the respondents No.4 in respect of 19836 Sq. The Registry is directed not to issue notice to the respondent Nos.1 to 6 in view of the above waiver.

Learned counsel for the petitioners is permitted to take out personal notices on the respondent Nos.7 to 14 by Speed Post with Acknowledgment Due (SPAD) and file proof of service in the Registry by the next date of hearing.

Learning counsel for the petitioners submits that this matter is connected with W.P.Nos.12967, 13918, 13939 and 13454 of 2026, which are pending adjudication and requested to post this matter along with the aforementioned Writ Petitions.
