WHEREAS the Petitioner above named through his Advocate SRI RAM PRASAD TEEGALA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction, more particularly one in the nature of writ of mandamus, declaring the inaction of the official respondents in failing to take action against the illegal construction being carried out by Respondent No.7 in Survey No.227 (Part), situated at Thonigandla Village, Ramayampet Mandal, Medak District, which is Government land earmarked as a playground (Kreeda Pranganam) and resumed by the authorities from the original assignees, namely Chakali Nagaiah and Chakali Narsawa, pursuant to representations dated 13.04.2026 and 20.04.2026, as illegal, arbitrary and violative of Articles 14 and 21 of

the Constitution of India, and consequently direct the respondents to forthwith remove the said illegal construction and encroachment, restore the said Government land to its original status as a playground.

AND WHEREAS the High Court upon perusing the petition and memorandum of affidavit filed herein and upon hearing the arguments of Sri. RAM PRASAD TEEGALA Advocate for the Petitioner, GP FOR REVENUE, for the respondent Nos. 1& 2 & 4, GP FOR PANCHAYAT RAJ, for the respondent No. 3 and Sri K Pradeep Reddy, standing Counsel for the respondent Nos. 5 & 6, directed issue of notice to the Respondent No.7, herein to show cause as to why this WRIT PETITION should not be admitted.

You viz:

Methuku Siddaramulu, R/o Laxmapur Village, Ramayampet Mandal, Medak District.

are directed to show cause on or before 05.05.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

I.A. NO: 2 OF 2026

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to Direct the respondents to maintain status quo in respect of the land bearing Survey No. 227 (Part), situated at Thonigandla Village, Ramayampet Mandal, Medak District, which is Government land earmarked as a playground (Kreeda Pranganam) and resumed from the original assignees, namely Sri Chakali Nagaiah and Smt. Chakali Narsawa and consequently restrain Respondent No. 7, his men, agents or anybody claiming through him from carrying on any further construction or raising any structures there on, pending disposal of WP No 12936 of 2026, on the file of the High Court.

The Court made the following:

ORDER

Issue notice to respondent No.7.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.7 and file proof of service by the next date of hearing.

It is the case of the petitioner that on his complaint regarding unauthorized construction being made by respondent No.7 in the Government land in Survey No.227 (Part) situated at Thonigandla Village, Ramayampet Mandal, Medak District, notice *vide* letter No. D/3088/2026 dated 16.04.2026 was issued by respondent No.4 directing respondent No.6 to submit the

documents/records. However, further action is not taken and respondent No.7 is proceeding with construction.

As it is stated that Ex.P3 - notice dated 16.04.2026 was issued and respondent No.7 is making unauthorized construction, respondent Nos.4, 5 and 6 are directed to stop unauthorized construction being made by respondent No.7 in the land in Survey No.227 (Part) situated at Thonigandla Village, Ramayampet Mandal, Medak District.
