WHEREAS the Petitioner above named through his Advocate Sri. Y BHARDWAZ presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the inaction of Respondent Nos. 2 and 3 in not taking any steps to prevent the illegal and unauthorized construction being Carried out by Respondent No. 4 in respect of the property bearing H.No. 6-26, Malyala Village, Chandurthy Mandal, Rajanna Sircilla District, as illegal, arbitrary and violative of the provisions of the Telangana Panchayat Raj Act, 2018, and consequently direct Respondent Nos. 2 and 3 to take immediate action in accordance with law and stop the said unauthorized construction,

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. Y BHARDWAZ Advocate for the Petitioner, directed issue of notice to the Respondent No.4, herein to show cause as to why this WRIT PETITION should not be admitted.
