Learned Additional Public Prosecutor takes notice on behalf of respondent No.1.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.2 by way of Speed Post with Acknowledgment Due and file proof of service.

Upon perusal of record, it reveals that the learned Magistrate, without giving an opportunity of hearing to the petitioner, as required under the proviso of Section 223(1) of the Bharatiya Nagarik Suraksha Sanhita, 2023 (for short 'BNSS'), referred the matter to the police for investigation. Basing on the same, Crime No.701 of 2025 was registered against the petitioner for the offences punishable under Sections 318, and 316 of the Bharatiya Nyaya Sanhita, 2023.

Post on 06.07.2026.

Till such time, there shall be an interim stay of all further proceedings against the petitioner/accused in F.I.R.No.701 of 2025 of Attapur Police Station, Cyberabad Commissionerate.

In default of filing proof of service, the stay stands vacated.
