WHEREAS the Petitioner above named through her Advocate SRI SRINIVASA MURTHY CHEEDELLA presented this Petition under Article 226 of the Constitution of

India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, order or direction more particularly one in the nature of Writ of Certiorari.

- (a) To call for records pertaining to the impugned Proceedings No.TBYB/A/728/2025 dated 16-03-2026 passed by the Respondent No.2 declaring the respondent No.3 as owner and shall remain owner of the lands covered by Survey No. 336 and 337 of Agirala Village by rejecting the claim of the petitioner for issuance of No Objection as bad, arbitrary, illegal, capricious and contrary to provisions of the Telangana Bhoodan and Gramdan Act 1965 and Rules in that regard including Sri Acharya Vinobha Bhave Sarvodaya Bhoo Yagna, Hyderabad Land Revenue Special Rules of 1951 besides violative of Article 14, 300-A and Art. 21 of the Constitution of India and Quash the same.
- (b) to direct the respondents to delete the lands in survey numbers 336 and 337 of Agirala Village from Bhoodan Yagna Board Records,
- (c) further direct all the Respondents to delete the Survey Nos. 336 and 337 of Agirala Village from Prohibited List U/s. 22-A of Stamps and Registration Act;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI SRINIVASA MURTHY CHEEDELLA Advocate for the Petitioner, GP FOR REVENUE appearing for the Respondents no. 1, 4 and 5 and SRI GATTU KIRAN KUMAR, Standing Counsel for TELANGANA STATE BHOODAN YAGNA BOARD (TSBYB), appearing for the Respondents no. 2 and 3 directed issue of notice to the Respondents no. 6 to 10 herein to show cause as to why this WRIT PETITION should not be admitted.
