No. 4 and 5 in interfering into the petitioners and unofficial respondents civil dispute and time and again calling the petitioners to their offices in collusion with the unofficial respondents and threatening to compromise with them as illegal, arbitrary and against the principles of natural justice and in contrary to the law. No. 4 and 5 not to interfere into the petitioners and unofficial respondents civil dispute without any valid reason in contrary to law.
