Learned counsel for the petitioner is permitted to take out personal notice to respondent No.2 through speed post with acknowledgment due and file proof of service.

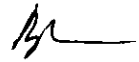

Taking into consideration the occupation of the petitioner, his presence in S.T.C.NI.No.729 of 2024 on the file of the II Additional Junior Civil Judge-cum-X Additional Chief Metropolitan Magistrate, at Kukatpally is dispensed with, subject to the condition that he shall be represented through his counsel on each and every date of hearing. If the presence of the petitioner/accused is required, he shall appear before the trial Court. In case of non-appearance on the specific date fixed by the trial Court for his appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
