No. 719 of 2024 on the file of II AJCJ CUM X Addl. Chief Metropolitan Magistrate, Kukatpally for the offences punishable U/sec.138 IPC, as against the petitioner herein.

JILLELLA RAJESWARA RAO Advocate for the Petitioner, PUBLIC PROSECUTOR for the respondent No.1 directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

Petition under Section 528 of B.N.S.S. praying that in the circumstances stated in the grounds filed in support of the CRIMINAL PETITION, the High Court may be pleased to grant stay of all further proceedings, including the appearance in STC NI. Chief Metropolitan Magistrate, Kukatpally registered for the offence punishable under Section 138 of NI Act, pending the disposal of the above Criminal Petition.

Notice before admission.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.2 through speed post with acknowledgment due and file proof of service.

Learned counsel for the petitioner submits that the petitioner is discharging his duties as a Doctor and it is very difficult for the petitioner to appear on each and every date of adjournment in the trial Court and the matter before the trial Court is not yet ripe for trial and is at the stage of appearance.

Post on 03.07.2026.

Taking into consideration the occupation of the petitioner, his presence in S.T.C.NI.No.719 of 2024 on the file of the II Additional Junior Civil Judge-cum-X Additional Chief Metropolitan Magistrate, at Kukatpally is dispensed with, subject to the condition that he shall be represented through his counsel on each and every date of hearing. If the presence of the petitioner/accused is required, he shall appear before the trial Court. In case of non-appearance on the specific date fixed by the trial Court for his appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
