RAM SINGH presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus or any other appropriate writ, order or direction setting aside 3rd Respondent's Minutes of Meeting dated 10.07.2023 issued vide Lr.No.TAFRC/03/Medical/Dental/PG/Fee/2023 dated 14.07.2023, and consequential G.O.Ms.No.107, dated 28.07.2023 and G.O.Ms.No.131 dated 18.08.2023 issued by the Respondent No.1 as illegal, arbitrary, unconstitutional and violative of Articles 14, 19(1)(g) and 21 of the Constitution of India, and consequently direct the respondents to collect fees from the petitioner who comes under Category - B @ 70% of the amount payable as per G.O.Ms.No.107, dated. 28.07.2023 and G.O.Ms.No.131 dated 18.08.2023 issued by the Respondent No.1.
