(i) For candidates belonging to category – A, 60 % of the amount payable as per G.O.Ms. No.107, dated 28.07.2023 and G.O.Ms. No. 131 dated 18.08.2023 issued by respondent No.1.

(ii) For candidates belonging to category – B, 70% of the amount payable as per G.O.Ms. No. 107, dated 28.07.2023 W.P. No. 4902 of 2026 dated 18.08.2023 issued by respondent No.1.

(iii) The candidates, who fall within the ambit of either category – A or category – B, shall at the time of payment, furnish a personal bond undertaking to pay the remaining amount on disposal of the present Writ Petition, in case, the same is required to be paid.

Heard learned counsel for the petitioners.

For the reasons stated in the accompanying affidavit, there shall be interim direction as prayed for.

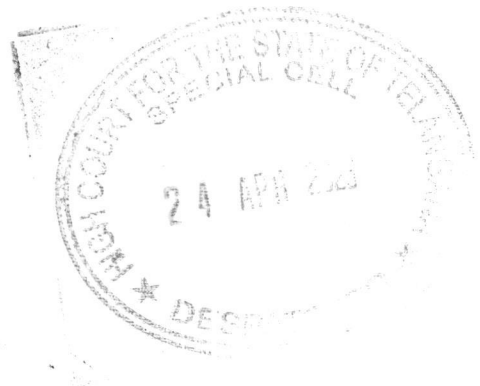
