The presence of the petitioners/accused Nos.2 to 4 in C.C.No.482 of 2026 on the file of the III Additional Junior Civil Judge-cum-Additional Judicial Magistrate of First Class, Ranga Reddy District at L.B.Nagar, is dispensed with, subject to the condition that they shall be represented through their counsel on each and every date of hearing. If the presence of the petitioners/accused Nos.2 to 4 is required, they shall appear before the trial Court. In case of non-appearance on the specific date fixed by the trial Court for their appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
