WHEREAS the Petitioner above named through his/her Advocate SRI PENUBALLI RAMESH BABU presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in nature of Writ of Mandamus declaring the actions the Respondent No.4 in not following the procedure established by law and Respondent No.5 in withholding the salary of Petitioner by getting issued warrants dated 06-11-2025 in EP No.384 of 2025 in ARB No.97 of 2023 on the file of I Additional Junior Civil Judge -cum- I Additional Judicial Magistrate of First Class Karimnagar as arbitrary, illegal and violative of principles of natural justice and consequently set aside proceedings in EP No.384 of 2025 in ARB No.97 of 2023 pending before the I Additional Junior Civil Judge -cum- I Additional Judicial Magistrate of First Class Karimnagar along

with the warrants dated 06-11-2025 issued by the Honourable I Additional Junior Civil Judge -cum- I Additional Judicial Magistrate of First Class Karimnagar and direct the Respondent No.5 to not deduct the salary of the Petitioner in the interest of justice:

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri PENUBALLI RAMESH BABU, Advocate for the Petitioner and GP for Stamps and Registration for the respondent Nos.1 to 3, directed issue of notice to the Respondent Nos.4 & 5 herein to show cause as to why this WRIT PETITION should not be admitted

are directed to show cause on or before 20-07-2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant stay of all proceedings in EP No.384 of 2025 in ARB No.97 of 2023 on the file of I Additional Junior Civil Judge -cum- I Additional Judicial Magistrate of First Class Karimnagar along with the Salary Attachment Warrants dated 06-11-2025 issued by the file of the I Additional Junior Civil Judge -cum- I Additional Judicial Magistrate of First Class Karimnagar, pending disposal of WP No 13053 of 2026, on the file of the High Court.

The Court made the following:

ORDER

Notice before Admission.

Learned Government Pleader for Stamps and Registration takes notice on behalf of respondent Nos.1 to 3, waives further notice and seeks time to file counter-affidavit.

Registry is directed not to take out further notice to respondent Nos.1 to 3, in view of the above waiver.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.4 through speed post with acknowledgment due and file proof of service in the Registry by the next date of hearing.

Learned counsel for the petitioner submits that the Division Bench of this Court, in *Punyamuthula Venkata Viswa Sundara Rao v. Margadarsi Chit Fund Private Limited, Hyderabad and others* [reported in 2017 (3) ALD 387], held that the E.P. Court does not have jurisdiction to entertain an application for execution of the award of the Deputy Registrar of Chit Funds, if presented by the decree-holder. However, in the instant case, respondent No.4 straight away filed E.P. before learned I Additional Junior Civil Judge-cum-I Additional Judicial Magistrate of First Class, Karimnagar. Therefore, learned counsel seeks indulgence of this Court.

In view of the above submission and the decision referred above, there shall be an interim stay as prayed for, insofar as the petitioner is concerned.

Post this matter on 20.07.2026 for counter-affidavit.
