JILLELLA RAJESWARA RAO presented this Petition under Section 528 of B.N.S.S. praying that in the circumstances stated in the grounds filed in support of the CRIMINAL PETITION, the High Court may be pleased to quash the STC NI. No. 734 of 2024 on the file of II AJCJ CUM X Addl. Chief Metropolitan Magistrate, Kukatpally for the offences punishable U/sec.138 NI Act, as against the petitioner herein.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Ms. Anusha Mamidi, counsel representing Sri. JILLELLA RAJESWARA RAO Advocate for the Petitioner, and Additional Public Prosecutor, for the Respondent No.1 directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

are directed to show cause on or before 03.07.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the memorandum of grounds filed therewith (copy enclosed) this CRIMINAL PETITION should not be admitted.

I.A. NO: 1 OF 2026

Petition under Section 528 of B.N.S.S. praying that in the circumstances stated in the grounds filed in support of the CRIMINAL PETITION, the High Court may be pleased to grant stay of all further proceedings including appearance in STC NI. No. 734 of 2024 on the file of II AJCJ CUM X Addl. Chief Metropolitan Magistrate, at Kukatpally, for the offence under Section 138 of NI Act pending the disposal of the above Criminal Petition.

ORDER

Ms. Anusha Mamidi, learned counsel representing Mr. J.Rajeshwar Rao, learned counsel for the petitioner, submits that two similar Criminal Petitions i.e., Crl.P.Nos.6374 and 6384 of 2026 are pending before this Court and this Court, while ordering notice before admission, dispensed with the presence of the petitioners before the trial Court, on the ground that the matter before the trial Court was not ripe for trial. Hence, in this case also, the petitioner is entitled for the very same benefit.

Notice before admission.

Learned Additional Public Prosecutor takes notice on behalf of respondent No.1.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.2 through speed post with acknowledgment due and file proof of service.

Post along with Crl.P.No.6374 of 2026 and Crl.P.No.6384 of 2026 on 03.07.2026.

The presence of the petitioner/accused in STC NI No.734 of 2024 on the file of the II Additional Junior Civil Judge cum X Additional Chief Metropolitan Magistrate at Kukatpally is dispensed with, subject to the condition that he shall be represented through his counsel on

each and every date of hearing. If the presence of the petitioner/accused is required, he shall appear before the trial Court. In case of non-appearance on the specific date fixed by the trial Court for his appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
