No. 103/GP/2021-22, and Rc. No. 873/1/GPA/2022-23, shown in House tax register upto year 2022-2023 in respect of the petitioner's H. No. 2-181/C/, situated Paikajinagar (V),. Rajampet (GP), Asifabad (M), KB Asifabad District, made by the

4th respondent in favour of Respondents No. 6 and 7, including inaction of respondents No. 2, 3 and 4 on complaints dated 22.05.2023 and dated 23.03.2026 for cancelling the entries clandestinely made in the register, as illegal, arbitrary, discriminatory, ultra vires, null and void, against the statutory powers conferred under the law, against principles of natural justice and in violation of fundamental and constitutional rights of petitioner and consequently restore the entries house in favour of petitioner in the interest of justice.
